

As of July 1, 2002, Caltech requires that all doctoral candidates submit an electronic copy of their dissertation, which the Caltech Library System will then archive and make available online. Caltech has joined the Networked Digital Library of Theses and Dissertations (NDLTD), an international organization that allows researchers to globally search a database of electronic theses and dissertations. Recent experience indicates that archiving your dissertation in this manner can lead to extremely large increases in its visibility and availability to researchers in your field. At Virginia Tech, which has been a pioneer in this area, ten electronic theses and dissertations (ETD's) have been accessed over 6,600 times—the top one over 25,000 times!

In order to submit an electronic version of your dissertation, go to the Caltech ETD web site at <http://etd.caltech.edu/> and set up an account. From this site you may also browse the database and download theses that have previously been submitted. The current website was adopted, with a few customizations, from Virginia Tech software.

At least for the time being, the Caltech Library asks that submissions be limited to the following formats:

For the main text: preferably PDF, but PostScript or Microsoft Word files are also acceptable.

For the bibliography: if available, please submit your bibliography as a separate file, either in the form of a BibTeX file(s) or Endnote file(s).

Multimedia files: you may submit such files, but be aware that the Caltech Library cannot assure long-term archiving of them due to format changes that may subsequently occur.

As for copyright and publication status, the ETD submission form will ask you to agree to the following terms:

I hereby certify that, if appropriate, I have obtained and attached hereto a written permission statement from the owner(s) of each third party copyrighted matter to be included in my thesis, dissertation, or project report, allowing distribution as specified below. I certify that the version I submitted is the same as that approved by my advisory committee. I hereby grant to California Institute of Technology or its agents the non-exclusive license to archive and make accessible, under the conditions specified below, my thesis, dissertation, or project report in whole or in part in all forms of media, now or hereafter known. I retain all other ownership rights to the copyright of the thesis, dissertation or project report. I also retain the right to use in future works (such as articles or books) all or part of this thesis, dissertation, or project report.

You may choose to restrict access to your dissertation in various ways. You may prohibit all online access. You may restrict online access to on-campus users only (IP restricted), or you may selectively restrict access to parts of the ETD. These restrictions are in place until you notify the Library, or you may impose such restrictions for a specified period of time.

Currently, most, but not all, publishers do not consider the material contained in a web-available ETD to be a prior publication. Most, but not all, publishers do not consider it a violation of copyright if students include articles they have previously published in a web-available ETD. Please be aware, however, that publishers are continually re-evaluating their policies and business models as they adapt to the new realities of scholarly communication.

Please note that all electronic theses must be submitted online to the Caltech Libraries **no later than two weeks prior to the annual commencement ceremony** in order to receive a diploma. All feedback should be sent to etd@library.caltech.edu.
